

Altius Vendor Assessment Website Licence Agreement

Altius Vendor Assessment Limited provides the Altius Vendor Assessment Website (the 'Site') and Altius Vendor Assessment system.

By using the Site or downloading materials from the Site, you agree to abide by the terms and conditions of the Agreement between your organisation and Altius Vendor Assessment Limited, and this Licence Agreement. If you do not agree to abide by these terms you should not use the Site or download materials from the Site.

1. Limited Licence

1.1 Subject to the terms and conditions set forth in the Agreement and this Licence Agreement, Altius Vendor Assessment Limited (the 'Issuer') grants you a non-exclusive, non-transferable, limited right to access, use and display the Altius Vendor Assessment Website, the Altius Vendor Assessment system, and the information ('Materials') thereon.

1.2 By accepting the terms of this licence you agree to: -

- a) Keep your password secret and not share it with anyone.
- b) Keep your company's information up-to-date, accurate, and not provide misleading information. You understand that you and your organisation are liable for the information you provide and not Altius Vendor Assessment Limited. (Note: other users may form a negative view of your organisation if you provide insufficient, out-of-date, inaccurate or misleading information. Please make sure that your information is as accurate and helpful as possible to ensure you receive the most benefit from your participation in the Altius Vendor Assessment system).
- c) Use the system only for the purposes for which it is intended.
